Ten priority epithermal gold targets identified for follow-up at Bramaderos

Rock chip samples of up to 11g/t gold highlight the prospectivity

Key Points

- Exploration for epithermal gold in the western portion of the Bramaderos concession in Ecuador is generating highly promising results
- Trenching over the Bramaderos Vein has returned up to 2.1g/t gold and 7.7g/t silver over 0.9m
- Rock chip samples from the El Espiritu epithermal target have returned up to 11.63 g/t gold and up to 38.62 g/t silver
- Exploration at the West Zone epithermal target has resulted in improved interpretation of the geology of the epithermal belt
- The epithermal gold corridor within the Bramaderos concession, is an extension of the producing Dynasty Goldfield located ~5km to the south-west, and includes multiple targets representing significant exploration potential
- A detailed ground magnetic survey is in progress to refine target definition
- Drilling at West Zone identified anomalous epithermal gold values, but on reinterpretation did not test the revised target zones
- Ten targets have been defined based on soil geochemistry, rock chip sampling, geological mapping, alteration mineral mapping, and regional structural analysis and a ground magnetic survey is in progress to further refine target definition prior to drill testing

Sunstone Metals Limited (ASX:STM) announces that ongoing exploration within the western epithermal gold corridor within its Bramaderos project in Ecuador has defined ten targets for detailed follow-up ahead of drilling.




Figure 1: Regional view of the Bramaderos Project concession showing the 4-km-long 'Epithermal Corridor' which includes West Zone, as a continuation of the Dynasty Goldfield.




Figure 2: Plan view of the northern portion of the Bramaderos concession showing the epithermal corridor containing multiple targets (A-H and West Zone; labelled with the epithermal pathfinder elements relevant to each target), and the spatial relationship of this belt to the porphyry targets at Bramaderos Main and Limon. The extensive soil antimony and arsenic dispersion patterns (epithermal pathfinder elements) are shown surrounding the lithocap at Bramaderos vein and extending along the northeast-trending epithermal target trend.

These targets all sit within the Bramaderos epithermal gold corridor (Figures 1 and 2), which is the north-east extension of the gold producing Dynasty Goldfield located 5km to the south-west (held by TSXV listed Core Gold).

They include the Bramaderos Vein (Figure 2), where recent trenching returned results of up to 2.1g/t gold and 7.7g/t silver over 0.9m and where historical rock chip sampling returned up to 32.5g/t gold.

Other areas of gold mineralisation in rock chip samples include El Espiritu, where there is extensive pathfinder element signature in soil samples. Gold values include 11.63 g/t, 3.70 g/t, 1.80 g/t and 1.615 g/t while silver



values include 38.62 g/t, 26.67 g/t, 15.68 g/t and 10.84 g/t. These mineralised samples were collected from barite-bearing ferruginous quartz veins in gullies located approximately 700m northeast of Bramaderos hill, from target B shown in Figure 2.

A trenching program is being designed to test this area in a more systematic fashion. A rockchip-sampling program is also being designed to cover 5 of the epithermal targets that have strong pathfinder element signatures in soils but are yet to be surface sampled by rock-chipping.

Drilling at West Zone identified anomalous epithermal gold values (Table 1), but on re-interpretation did not test the revised target zones.




Figure 3: The West Zone area showing trench assay results (Sunstone and historic) and Sunstone drill hole locations and traces (red lines). The North Pod is significantly higher grade than the south pod at surface and drill hole WZDD002 may have drilled under the potentially shallow-dipping main epithermal zone. A shallow-plunging target zone may remain off the east and northeast edge of the North Pod as shown, and potentially on a similar structure to the east of the South Pod as shown.

The main target zone at West Zone is now interpreted to be related to the North Breccia Pod area as a structurally-constrained zone plunging to the east or north-east (Figure 3). Further drill targets have been identified.

QAQC (quality assurance/quality control) review and petrography have been completed at West Zone. The petrography confirms that some of the very high-grade surface gold values in trenches at West Zone is due to supergene enrichment.

Sunstone Managing Director Malcolm Norris said: "We are seeing a lot of evidence of epithermal style mineralisation within the belt and we know that this area is the north-east extension of the gold producing Dynasty Goldfield.

"We are very bullish about the targets that have been defined to date along this trend, and we plan to move those to drilling status as soon as possible."

"We have developed an improved interpretation of the West Zone target. Supergene gold enrichment, demonstrated at West Zone, may represent an opportunity within the belt."

About Sunstone Metals

Sunstone has an advanced portfolio of exploration and development projects in Scandinavia and Ecuador. The portfolio comprises:

- 1. **The Bramaderos Gold-Copper Project** where Sunstone owns an 87.5% interest with TSXV listed Cornerstone Capital Resources holding 12.5% (see ASX announcement dated 10th April 2017, 28th August 2019, and 7 January 2020). The Bramaderos gold-copper project is located in Loja province, southern Ecuador, and is considered to be highly prospective for the discovery of large porphyry gold-copper systems, and high-grade epithermal gold systems. Historical exploration results from drilling at Bramaderos together with recent exploration by Sunstone and joint venture partner Cornerstone Capital Resources (TSXV:CGP) indicate multiple fertile mineralised systems with significant discovery potential.
- 2. The Southern Finland Gold Project includes the Satulinmäki gold prospect. Shallow diamond drilling was completed by the Geological Survey of Finland (GTK) during the period 2000-2005 and this was followed by a 7-hole diamond drilling program by Sunstone Metals in 2016. Intersections from GTK include 18m @ 4.1g/t Au from 50m downhole, including 3m @ 9.3g/t Au, and 4m @ 10.3g/t Au in drill hole R391. Intersections by Sunstone include 23.5m at 3.3g/t in SMDD007 and 2m at 10.5g/t in SMDD005. The Satulinmäki gold prospect is part of an earn-in JV with Canadian company Nortec Minerals, where Sunstone holds an ~82% interest, is funding on-going work, and has also acquired a significant land position, in its own right, in the district.
- 3. **The Scandinavian Lithium Project** includes the Kietyönmäki lithium prospect. Drilling by Sunstone has delivered 24.2m at 1.4% Li₂O in a spodumene-bearing pegmatite. Kietyönmäki is also part of the JV with Nortec Minerals
- 4. **Sunstone has a significant equity** interest of ~31% in Stockholm listed Copperstone Resources (COPP-B.ST) following the recent sale of the Viscaria Copper project.
