## VISCARIA DRILL HOLE VDD 185 INTERSECTS 5.6m at 1.6% COPPER, and VDD 186 INTERSECTS A 35m THICK MINERALISED IRONSTONE

#### **Highlights**

- VDD 185 has intersected significant copper mineralisation outside the existing mineral resource area, in a down plunge position at Viscaria D Zone.
- Diamond drill hole VDD 185 has returned assays of:
  - o 10m at 1.2% Cu
  - o Including 5.6m at 1.6% Cu, including 2.1m at 2.3% Cu
- Drill hole VDD 186, also at Viscaria D Zone, has been completed at 563.2m and intersected a 35m thick variably copper mineralised and altered ironstone sequence from 464.5m to 541.5m (assays pending).

**Avalon Minerals Limited** ('Avalon' or 'Company') (ASX: AVI) is pleased to announce the assay results from diamond drill hole VDD 185 at Viscaria D Zone.

Assay results include:

10m at 1.2% Cu from 425.85m,

Including 5.6m at 1.6% Cu, including 2.1m at 2.3% Cu both from 425.85m




Figure 1 - Location of VDD 183, 185, and VDD 186 at the Viscaria Copper Project, D Zone






Figure 2 – Location on schematic long section of VDD 183, 185, 186 and 187 at the Viscaria Copper Project, D Zone.






Figure 3: Drill hole cross section containing VDD 185 and previously drilled diamond holes. VDD 185 is collared at 1680120mE and 7537014mN, at an RL of 521m.

Drill hole VDD 185 was completed at 479.7m and was drilled at -55 degrees towards 130 degrees (Figures 1 and 3). The intervals of mineralisation intersected in this drill hole are outside of the area containing the current estimated mineral resources (Figure 2). The results demonstrate that mineralisation is improving in thickness and grade with depth on drilled section (Figure 3).

In long section (Figure 2), the intersection was close to the margin of the interpreted sulphide lens and 300m from VDD 183 (3.5m at 2.2% Cu), but still returned a significant copper intersection and supports our confidence that the D Zone mineral resource estimate will grow.

VDD 186, which has been completed to a depth of 563.2m, was drilled between holes VDD 183 and 185 and has intersected a 35m thick ironstone sequence (downhole thickness) with visible chalcopyrite across multiple intervals (figure 4). This occurs within a broader 77m thick interval

of altered rock from downhole depth of 464.5 to 541.5m. Assay results are expected to be received in mid-June.

Drill holes VDD 183, 185 and 186, are all outside of the area of the current resource estimate, and demonstrate that the D Zone mineralisation continues to be open at depth. Drill hole targeting at D Zone is being directed by key resource estimate growth opportunities and in parallel with in-house mine planning scenarios.

Avalon's Managing Director, Mr Malcolm Norris said, "We are continuing to build on our interpretation of Viscaria D Zone and to bring focus on the interpreted areas of higher grade copper where they extend beyond the current resource estimate, and where those areas have a significant positive effect on our approach to in-house development planning scenarios."
